City of Marysville Solicitor Guidelines

(Summary of Codified Ordinance Section 7.13)



- Q. Who is required to obtain a solicitor's permit or license?** *(A.) Anyone going door to door in a residential area soliciting funds for goods or services. (Selling a product for profit).*
- Q. How do I get a solicitor's permit?** *(A.) You must complete an application at the Marysville Division of Police, located at 1250 W 5th St Marysville, OH 43040. You must have your permit in hand before soliciting.*
- Q. How much does it cost and what do I need to bring?** *(A.) For adults (those over 18 years of age) there is a \$75 license fee. Additionally, you must bring government issued identification with a photo. There is no charge for anyone requiring a permit that is under 18, however a permit is still required. There is also information requested, such as past soliciting activity and the business federal id number, which is to be supplied on the application. Your fingerprints and photo will be obtained as part of the application process.*
- Q. How long is the license valid?** *(A.) The license is valid for one year from the date of issue, unless revoked by the police for fraudulent information or failure to abide by the ordinance.*
- Q. Why would my application for a permit be denied?** *(A.) The application can be denied by the Chief of Police if the application contains false or misleading information; or if the applicant or enterprise constitutes a clear and present danger to the residents of the city.*
- Q. I am selling items for a non-profit organization, do I need to obtain a permit?** *(A.) Those soliciting for non-profit, charitable, or recognized religious organizations; as long as they are not compensated for the soliciting, are exempt from the permit requirement.*
- Q. What rules apply to my soliciting once a permit is issued?** *(A) You must conspicuously attach and exhibit the license on the outside of your clothing, and you must present the receipt, showing proof of purchase of the license, when asked. You may not solicit before 8am or after 8pm, or on any holiday as defined in ORC Section 1.14.*
- Q. What are the penalties for violating this ordinance?** *(A) The first violation is considered a minor misdemeanor; any subsequent offense is punishable as a first degree misdemeanor.*
