**SEWER TAPPER LICENSING  
CODIFIED ORDENANCE CHAPTER 717**

A Sewer Tappers license is required when any contractor or person desiring to conduct, carry on or engage in the business of tapping, building, excavate for, tap or construct any sewer, or excavate for any reason whatsoever, in any street, avenue, alley, lane, right of way or public place in the Municipality, except in cases of emergency.

Prior to the issuance of the license, the applicant shall post with the Municipality, a surety bond in the amount of five thousand dollars (\$5,000) issued by a surety company authorized to do business in the State, conditioned that such person shall guarantee proper execution and completion of the work authorized by any permit issued under such license for a period of one year after the expiration date of such license and shall completely restore to its original condition and to the full satisfaction of the Director of Administration, any street, alley, public grounds, sewer or any other structure or service which may have been opened or distributed by such person and shall strictly comply with the conditions and provisions of this chapter and with the conditions of any permit issued pursuant thereto. The initial fee or the annual renewal for any license hereunder shall be \$25.00.

All licenses issued under the provisions of this chapter shall expire at midnight, December 31 of the calendar year in which such license was issued.
