Marriage Ceremonies

The Marysville Municipal Court is authorized to perform civil weddings pursuant to Ohio Revised Code Section 1901.14 (A) (1). This service is provided free of charge.

In order to schedule a wedding ceremony, please complete a Wedding Ceremony Application which is available at the Clerk's Office of the Marysville Municipal Court, 1250 West Fifth Street, Marysville, Ohio between the hours of 8:00 a.m. to 4 p.m., Monday through Friday.

Weddings are set on **Mondays at 1:30 p.m.** according to the next available date. For special circumstances, a wedding might be scheduled on another day and time.

Guests are welcome to attend. Photographs and videos are permitted. Flowers are also permitted. The Court will make every reasonable attempt to hold the ceremony in a manner desired by the couple. A couple will be asked during the ceremony if they wish to make any statement of their commitment to each other. A word about rings. Rings are not required. However, a ring is said to be the outward symbol of the couple's commitment to one another. The rings can be traditional gold bands or a very simple ring of any material. We will need to know if you will want to exchange rings during the ceremony. It is our intention to make the wedding ceremony special for you on your wedding day.

It is our honor and pleasure to join you in marriage. We look forward to providing this service for you.
